### INDEPENDENT AUDITOR'S REPORT

To the Members of Oswal Pumps Limited Delhi

### Report on the Financial Statements

We have audited the accompanying financial statements of **Oswal Pumps Limited** ("the Company"), which comprise the balance sheet as at March 31, 2022, and the Statement of Profit and Loss and statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies and other explanatory information.

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid financial statements give the information required by the Companies Act, 2013 ('Act') in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India, of the state of affairs of the Company as at March 31, 2022, its profit and cash flows for the year ended on that date.

### Basis for opinion

We conducted our audit in accordance with the standards on auditing specified under section 143 (10) of the Companies Act, 2013. Our responsibilities under those Standards are further described in the auditor's responsibilities for the audit of the financial statements section of our report. - i)(a) The Company has maintained proper records showing full particulars, including quantitative details and situation of Property Plant & Equipments;
  - (b) The Property Plant & Equipment have been physically verified by the management in a phased manner, designed to cover all the items over a period of three years, which in our opinion, is reasonable having regard to the size of the company and nature of its business. Pursuant to the program, a portion of the fixed asset has been physically verified by the management during the year and no material discrepancies between the books records and the physical Property Plant & Equipment have been noticed.
  - (c) According to information and explanations given to us and on the basis of our examination of the books of account, and the company is operating on a rented premises taken on lease. The company have no title except covered under the lease on the building constructed on the said property.
  - (d) The Company has not revalued its Property, Plant and Equipment or intangible assets during the year ended 31st March 2022.

As informed by the assessee, the information reported under clause 44 of Form 3CD is based on the information extracted from accounting software/ relevant GST report. However this may not be accurate as the accounting software used by Assessee is not configured to generate report as required under this clause in absence of any statutory requirement. In addition, software/system does not capture information relating to the entities falling under composition scheme or supply with ineligible credit. Therefore, it is not possible for us to verify the break-up of total expenditure of entities registered or not registered under the GST and unable to comment on accuracy of information provided therein. Total expenditure reported under the clause includes capital expenditure however does not include depreciation, bad debt and expenditure which is not a supply as per GST.

## NOTES FORMING PART OF ACCOUNTS

NOTE '1'

#### Corporate Information

Oswal Pumps Limited ("the Company") is a company having CIN U74999DL2003PLC121307 is engaged in the business of manufacutring of electrical motors and solar pumping set, submersible pumping sets and whole sale trading with registered office situated at C-5/2A, Rana Pratap Bagh, Opp CC Colony, Delhi. The activities of the company comprises only two business segment viz wholesale trading and Manufacturing. The Corporate Office of the company is located at VPO Kutali, Distt. Karnal-132037

#### NOTE '2'

#### 2.1 Accounting Standards

The Company is Non SMC as defined in the General Instructions in respect of Accounting Standard notified under the companies (Accounting Standards) Rules, 2006 (as amended). Accordingly, the Company has compiled with accounting Standards as applicable to a Non Small and Medium Sized Company.

# 2.2 Basis of Accounting and Preparation of Financial Statements

The financial statements of the Company have been prepared in accordance with the Generally Accepted Accounting Principles in India (Indian GAAP) to comply with the Accounting Standards notified under the Companies (Accounting Standards) Rules, 2006 (as amended) and the relevant provisions of the Companies Act, 2013. The financial statements have been prepared on accrual basis under the historical cost convention. The accounting policies adopted in the preparation of the financial statements are consistent with those followed in the previous year except for adjustments required to complife financial accounts in accordance with the revised sheedule VI.

#### 2.3 Use of Estimates

The preparation of the financial statements in conformity with Indian GAAP requires the Management to make estimates and assumptions considered in the reported amounts of assets and liabilities (including contingent liabilities) and the reported income and expenses during the year. The Management believes that the estimates used in preparation of the financial statements are prudent and reasonable. Future results could differ due to these estimates and the differences between the actual results and the estimates are recognised in the periods in which the results are known / materialise.

#### 2.4 Cash flow statement

Cash flows are reported using the indirect method, whereby profit / (loss) before extraordinary items and tax is adjusted for the effects of transactions of non-cash nature and any deferrals or accruals of past or future cash receipts or payments. The cash flows from operating, investing and financing activities of the Company are segregated based on the available information.
